- 2. You must advise us of any changes to your contact details within 10 working days.
- 3. You can revive your suspended licence at any time. Please refer to the website (<u>rea.govt.nz/suspend</u>) for further information on reviving your licence.
- 4. Levies paid are not refundable. No refunds paid if a licence is revived.
- 5. The licence will be suspended from the date specified. The suspension start date must be on or after the date you submit the notice. You cannot suspend your licence retrospectively or after the expiry date of your licence.
- 6. If you are suspending for more than one year, please note you will have to pay the annual suspension fee each year. This is due on the anniversary date of the original suspension.

#### Privacy and information handling

The Real Estate Authority will collect, use, hold and disclose your personal information only for the purposes as provided for under the Real Estate Agents Act 2008 and regulations, Privacy Act 2020, Public Records Act 2005, or otherwise as permitted or required by law.

Under the Privacy Act 2020 you may request access to and request correction of your personal information held by the Real Estate Authority.
