# Under the provisions of Regulation 10 of the Real Estate Agents (Audit) Regulations 2009 the following may be appointed as auditor

  - a. is a qualified auditor; and
  - b. is not disqualified from auditing the agency's trust accounts under regulation 11.
- 2. See <u>sections 37 to 39</u> of the Financial Reporting Act 2013 (which provide for the appointment of a partnership and access to information in relation to an agency).
